



### Policy Provisions Regarding Use of CHS Field for Baseball Games

1. Games must start on time as scheduled. No exceptions. Infield practice and the review of ground rules should take place prior to the scheduled starting time and should not be reasons for a late start. If infield practice delays on-time starts, infield practice privileges may be denied for future games. In the interest of equality and to preserve field conditions, a team's infield practice is limited to ten (10) minutes or less.
2. **No cleats will be worn during warm-ups or infield practice.**
3. During infield practice all infielders, catchers, pitchers, and coaches must stay on skinned areas.
4. The grounds crew will be given ten (10) minutes after infield practices to remove all field protection.
5. In the event of a forfeit, due to lack of players by one or both teams, the field may not be used for any type of scrimmage or "pick-up" game.
6. Grounds crew will be given thirty (30) minutes between games to repair mound, plate, and infield skin, and water if needed, determined by Head Groundskeeper or his representative.
7. Teams will make their own arrangements for retrieving foul balls.
8. **No running on track between innings by players on the bench.**
9. Concessions are operated by Professional Sports Catering/Levy Restaurants, the exclusive concessionaire of the St. Paul Saints Baseball Club and CHS Field. The decision to open a concession stand will be made by Professional Sports Catering/Levy Restaurants and St. Paul Saints Baseball Club
10. Use of lights will be determined by the umpires and a representative of the Ballpark's management. If field lights are requested, they will be billed to the Client/User at a rate of \$75/hour In the event of lightning or the threat of lightning, field lights cannot be used.
11. The locker rooms will not be available for participating teams.
12. Only one bullpen will be available for use by all teams.
13. Teams will have access to field one (1) hour prior to game time, unless previous game runs past time at which point Tournament Manager and Event Manager will determine reasonable access to the field. Coaches and managers must assume full responsibility for the conduct of players during the baseball program's use of the Ballpark.
14. No Gatorade or water cooler dumping on field.
15. **No sunflower seeds allowed in any areas during play.** A cleaning charge will be assessed if this policy is not upheld by participating teams.
16. The decision to cancel a game due to weather or unplayable field condition prior to the game will the responsibility of the Head Grounds Keeper or his representative. The decision to cancel due to weather or unplayable field conditions during a game will be the umpires' responsibility, with input from the Head Grounds Keeper or his representative.
17. In all correspondences, please refer to the venue as CHS Field. No other name or reference to the ballpark should be used at any time.
18. Teams are responsible for leaving the dugout in the condition it was found: garbage picked up, no sunflower seeds. Teams are responsible for damages incurred during their game to the benches, railing padding, netting and any signage. Damage fees and penalties will be assessed.
